## **NOTIFICATION**

No. GG/90/2019/DYS/1003/2544/B :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Armed Deputy Superintendent of Police / Assistant Commandant / Adjutant and Battalion Quarter Master, Class I, in the Gujarat State Reserve Police Service, namely:-

- 1. These rules may be called the Armed Deputy Superintendent of Police / Assistant Commandant / Adjutant and Battalion Quarter Master , Class I, in the Gujarat State Reserve Police Service Recruitment Rules, 2019.
- **2.** Appointment to the post of Armed Deputy Superintendent of Police / Assistant Commandant / Adjutant and Battalian Quarter Master, Class I, in the Gujarat State Reserve Police Service, shall be made either,-
  - (a) by promotion of a person of proved merit and efficiency from amongst the persons, who,-
    - (i) have worked for not less than eight years in the cadre of Company Commander or Armed Police Inspector, Class II, in the Gujarat State Police Service;
    - (ii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006;
    - (iii) possesses the valid driving licence for Light Motor Vehicle; and
    - (iv) have passed the physical efficiency test as may be prescribed by the Government :

Provided that where the appointing authority is satisfied that a person having an experience as specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period as specified in sub-clause (i) above:

Provided further that on sub-clause (iii) shall come into force after one year from the date of publication of this notification in the *Official Gazette*:

or

- (b) by temporary transfer of a person on deputation basis from amongst the persons working in the cadre of Deputy Superintendent of Police (Unarmed), Class I, in the Gujarat State Police Service.
- 3. The candidate appointed by promotion shall be required to undergo such training and pass such examination as may be prescribed by the Government.
