No. GG/80/TTC/10(2002)/1317/Part-2/V:- In exercise of the powers conferred by clause (s) of section 2 of the Code of Criminal Procedure, 1973 (2 of 1974) in its application to the State of Gujarat, the Government of Gujarat, hereby amends the Government Notification, Home Department No. GG/95/TTC/10(2002)/1317/V, dated the 11th November, 2005, as under:-

In the said notification, in the Schedule,-
